The legal basis under the UK GDPR for our processing activities is public task (article 6(1)(e)) and Article 9(2)(g), as our processing is necessary for the performance of a task carried out in the public interest.

How long we will keep your personal data

NSPARC will keep your personal data for at least 2 years, after which if you do not confirm you are happy to remain on the mailing list NSPARC will destroy your personal data.
